Respective responsibilities of the body and the auditor

The body is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The body prepares an annual return in accordance with proper practices which:

- summarises the accounting records for the year ended 31 March 2015; and
- confirms and provides assurance on those matters that are important to our audit responsibilities.

Our responsibility is to review the annual return in accordance with guidance issued by the Audit Commission (see note below). Our work does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and does not provide the same level of assurance that such an audit would do.

External auditor report (ACCA0273)

Except for the matters reported below, on the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

We note that the Council has not confirmed compliance with the governance assertions in Section 2, Boxes 5 and 8, but has provided us with explanations, including details of the actions to address weaknesses identified.

In the completion of Section 4, the Annual Internal Audit Report, and their detailed report, the internal auditor has drawn attention to weaknesses in relation to risk assessment, and has made various other recommendations. The Council must ensure that action is taken to address these areas of weakness in a timely manner.

The Council has failed to publish the audited Annual Return by 30 September 2015, the date required by the Accounts and Audit (England) Regulations 2011. This was due to challenge correspondence received by the appointed auditor that had to be addressed before the External Auditor Report could be issued.
