The project provides a mobile warden who is available to visit and assist older people in their own homes and also provide other services such as collecting prescriptions and shopping. The warden makes a daily phone call to those on the scheme and this then ascertains what level of support if any is needed that day.

b) Who will benefit from the proposed project or scheme and how many of these are Waterbeach residents?

Older members of the community who require assistance to remain in their own homes rather than being forced to move into residential care. The number of clients varies but currently there are 10 people on the books of whom all but one are residents of Waterbeach and Chittering.

The scheme has proven very successful and has supported a number of older people in Waterbeach, Landbeach and Chittering. A report on the activities was presented to the April meeting of WPC and is also published in the latest edition of Beach News.

South Cambridgeshire District Council have indicated that future support may be influenced by how much WPC is prepared to contribute.

Note that the finances of the scheme are held in a restricted fund by AgeUK and any surplus / deficit at the year end will be carried forward to the following year. The brought forward total in the attached budget comes from an underspend in 2020-2021 and income from a collection organised by the family of a deceased member of the scheme
