Public Art Contribution - Bannold Road development

Donna Lynas, Waterbeach Cultural Collective, explained the process of handling the Public Art Contribution in the Section 106 for the Bannold Road development. The Artists Brief had been circulated to councillors and sent to Morris Homes who would prefer for an object of art within the site. Councillors considered that the Brief should have been broader in content. It was agreed that any information relating to the Brief should be sent to the clerk for forwarding to Donna Lynas. Reported that the western boundary of the recreation ground had been staked and wired in 1998 to prevent the hedge being trodden down.

A10 ditch – an update of the actions resulting from a meeting held with Mr Gillett, Environment Agency, in early 2009 was requested. It was agreed that flooding in all areas to be itemised would be discussed on the April agenda.

Mr Leeke proposed, seconded by Mr Wright and agreed that the Minutes of the meeting be signed.

2009/299 Clerk's report and matters arising from the Minutes

i.Gap in hedge (minute 2009.209,258 and 275)— all suggestions made by the council to obtain a risk assessment have been followed up. To date no progress has been made. Ian Dewar, CPALC, for advice as to where to obtain an assessment.

Councillors noted that CPALC have arranged a course on playground safety training by the person who assessed the gap.

ii.Pavilion electricity – the Meter Operator Person did not attend the appointment. A complaint has been made to the Head of Account Management and no reply received despite resending the e.mail. A further meeting has been made for 10th March for MOP, the DD has been cancelled. Photographs of the meter and readings were sent to the account manager on 25th February.

lii Dirt ramps – information regarding construction and risk assessment being sought from Chicksands Bike Park. It has been advised that such areas are usually fenced off and a disclaimer notice displayed. It was agreed that if the area was to be fenced off a site meeting should be held.

iv. Agreement for Capital Funding – received from Steve White and being reviewed by Alan Ball and clerk

v.Circus Tyanna – small circus taking up little space, pulling on on Sunday evening, opening Wednesday to Sunday and leaving on Sunday. Fully contained with own toilets. It was agreed that permission be granted for the circus to operate from the Green.

vi. Groundsman – Kevin Stubley has handed in his notice for end of March.

It was agreed that the Employment Panel should consider the options of re-appointing a full time groundsperson, arranging two part time persons, or engaging contractors. It was agreed that the Employment Panel should assist the clerk in this task.

The clerk had established that the Future Job Fund position would not be suitable for the position as a new job had to be created for the Fund.

A meeting would be held on 9th March. Any position would be advertised locally.

Football pitch safety – it was agreed that Kevin Stubley be asked if he would continue to determine if pitches are suitable to be played on.

vii. Chittering solar powered street light – cost of replacement panel £1093.94 + VAT. CCC not prepared to pay or contribute. CCC have been reminded of the minute which states that they would contribute and adopt if the installation was immediate. SCDC contacted to request contribution to repair. CCC is investigating the cost of converting the light to electric. Mr Williamson agreed to pursue this investigation.

viii.Highway site meeting – report attached and recommendations in consultation with David Lines for double yellow lines

A 'Stop Notice' had been issued on 2nd March which prevented any building work being done until the surface water drainage scheme is in place. A copy of the notice would be requested for circulating to all councillors by the clerk.

ii. To receive report of meeting of Management Task

A meeting had been held with Philip Peacock, ACRE, to discuss management options for Tillage Hall. A further meeting is to be held week beginning 15th March. It was reported that Mark Clack and Jacqui Rabbett of the Community association are attending the meetings. Emphasis should be made to the fact that the Tillage Hall project is for the whole community and that part of the project is to upgrade the path across the recreation for the benefit of all parishioners using the recreation ground

It was agreed that the re-drafted County Council agreement would be circulated to the Task Force once received by the clerk

2009/306 To consider action to be taken with regard to tree in Clare Close

Letter from Anglian Water putting the Council, as they had admitted responsibility for the tree, on notice that they reserve the right to recover any repair costs occasioned by tree root to its sewer. Letter from Granta Housing, social registered landlord of 13 Clare Close, informing the Council that they would look to recover any further costs incurred due to damage caused by the roots of the tree.

The clerk proposed discussing the matter further with Shaun Walker at the annual review meeting. It was further suggested that it should be determined what the conditions of the wayleaves granted.

An estimate to remove the tree and grind the roots had been obtained in 2009 for £850 which is now out of date. The cost of removal may therefore be increased. Mr Wright proposed, seconded by Mr Johnson and agreed that the tree should be removed. Dr. Grant opposed the decision.

It was agreed that the existence of the other trees in Clare Close should be reviewed.
