Beech hedge a children's play area – further reduction of larger twigs especially on play area side of hedge and top is needed. 51 beech hedge required to infill all beech hedges. Agreed.

Fruit trees on land adjacent to Beach Social club garden – badly damaged by careless grasscutting. Hand cutting or careful strimming recommended in future.

Recommend that berberis in front of groundsman's shed is moved back to edge of building and six hawthorn trees planted in place of exisiting berberis hedge in an attempt to stop further damage to box section on shed. Agreed
