5. Planning Matters:

- i. To consider planning applications:
 - a. Mr. Mrs. Lombardi, 18 Jubilee Close extension. Approved subject to neighbour.
 - b. Greene King Pub Partners, The White Horse erection of awning to front elevation. Refused. The ownership marking on the site plan is incorrect. Most of the frontage of The White Horse is part of the highway, it is understood that only 1m at the front belongs to the white Horse. The Council are concerned that the canopy area will be used as a smoking area and therefore cause inconvenience to members of the public using the highway. The canopy appears to protrude of the highway. The canopy will have a detrimental visual impact to the conservation area. The PC believe that there should be a Conservation Area Consent application. The Council have concerns about the hardboard sign erected around the pub sign with no permission.
- ii. SCDC planning application replies: there were none.
