### 2010.p61 To consider issues relating to:

i. Scimitar Homes, Waterbeach Lodge

Planning approval has been given to the application for a 40 bedroom care home. It was noted that no consideration was given to the comments or the concerns of the council in their response or when presented at the meeting by district councillors. In particular there is concern regarding the provision for parking.

It was agreed that SCDC planning be requested to notify the Council of all planning applications to be determined at SCDC planning committee in order that the Council could ensure adequate representation at the meeting

ii. Station yard

Network Rail have informed the Council that there is no breach of planning permission of highway condition. The matter would be investigated by Mr Johnson and Mr Hockney and raised at the Fen Line Users meeting in October.

iii. Bannold Road development

Concern was expressed that the balancing pond is full of water and the play equipment has not been installed .

SCDC enforcement officers have visited the site. The district councillors would determine the number of houses occupied on the new area.

Bannold Road reinstatement – SCDC enforcement consider that it is a matter for CCC highways enforcement.

iv. Housing Needs Survey

Extremely good response to the survey has been reported. Catharine Shilton, ACRE, and Darren Blake, Circle Anglia, will be attending the November planning meeting when it is hoped that all councillors will attend.
