Presentation by Catherine Shilton, ACRE Rural Housing Enabler, and Darren Blake, Circle Anglia Development Manager of the Housing Need Survey Report.

The survey shows an extremely high need for development of affordable rural housing under the Rural Exception Sites Policy to provide either rented or shared ownership for those with local connections. A site on the western and eastern edge of the village outside the village envelope had been identified as potential sites for development. Additional sites were identified by councillors and noted. Ownership of the sites to be confirmed and considered by Circle Anglia for investigation

S/1867/10: Milton Inns Ltd., 84 Way Lane – erection of two houses following demolition of existing dwelling. **Refuse**. Overdevelopment of site, height of proposed houses out of keeping with street

scene and significant impact on neighbours. No provision for turning on site to enable vehicles not to be backed out onto road particularly for property on north of site and especially with close proximity of junction with Fenleigh Close and rear access to school where the only footpath along Way Lane runs across the frontage of the site.
